House Bill 1226 (Delegate Schisler)
Economic Matters

Talbot County - Alcoholic Beverages (Pub- and Micro-Brewery Licenses)

This bill includes Talbot County among the jurisdictions in which pub-brewery and micro-brewery licenses may be issued by the State Comptroller. A holder of a pub-brewery license in the county may sell malt beverages for off-premises consumption in sealed refillable containers. The bill also allows a holder of a micro-brewery license in the county to sell beer to customers at retail for off-premises consumption in refillable containers that are sealed by the licensee at the time of each refill. The Comptroller's Office must specify which local license is the equivalent of a Class B beer, wine, and liquor license.

Fiscal Summary

State Effect: General fund revenues would increase by \$1,230 in FY 1998, and by \$530 annually thereafter, for each license issued. Expenditures would not be affected.

Local Effect: None. It is assumed that an existing restaurant in Talbot County would receive either a pub-brewery or micro-brewery license.

Small Business Effect: Potential meaningful effect on small businesses as discussed below.

Fiscal Analysis

State Revenues: It is expected that either one pub-brewery or micro-brewery license would be issued annually in Talbot County. This license would generate an annual license fee of \$500, an initial issuance fee of \$200, and a renewal fee of \$30. Fiscal Services expects the first license to be issued in fiscal 1998. Because licenses are renewable May 1 annually, the State would collect two license fees in fiscal 1998. As a result, general fund revenues would increase by \$1,230 in fiscal 1998 due to the two license fees, the issuance fees, and the renewal fee. Future-year revenues would increase by \$530 annually reflecting the annual license fee and renewal fee.

Small Business Effect: Currently, there are eight micro-breweries and three pub-breweries operating in Maryland. Based on 1995 figures, this industry generated between \$8 million and \$10 million in revenues, including the restaurant businesses. According to the Comptroller's Office, micro-breweries produced approximately 211,000 gallons of beer in 1995 and 276,000 gallons in 1996. Under the bill, the Comptroller can issue a micro-brewery license and/or a pub-brewery license in Talbot County. It is expected that only one restaurant would seek such a license, and its operations would be impacted favorably. If other small businesses seek such licenses, their operations would be similarly affected.
