1 AN ACT concerning

2 **Governor's Wellmobile Program**

3 FOR the purpose of establishing the Governor's Wellmobile Program to provide
4 primary and preventive health care services to certain populations and
5 communities; specifying the purposes of the Program; specifying the geographic
6 areas that the Program will serve; providing that the Program shall be operated,
7 managed, and administered by the University of Maryland School of Nursing;
8 providing for the funding of the Program; ~~establishing an advisory board for the~~
9 ~~Program~~ the Governor's Wellmobile Program Advisory Board; specifying the
10 membership of the ~~board~~ Board; specifying the terms of ~~the initial~~ certain
11 members of the ~~board~~ Board; specifying the duties, purpose, leadership, and
12 minimum meeting requirements of the ~~board~~ Board; authorizing the University
13 of Maryland, Baltimore to establish a nonprofit organization to accept certain
14 grants and donations to the ~~program~~ Program; requiring the School of Nursing
15 and the ~~board~~ Board to submit a certain annual report to the Governor and the
16 General Assembly; requiring the Office of Legislative Audits to perform a

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 10 MARYLAND, That the Laws of Maryland read as follows:

11 **Article - Health - General**

12 **SUBTITLE 10. GOVERNOR'S WELLMOBILE PROGRAM.**

13 13-1001.

14 (A) THERE IS A GOVERNOR'S WELLMOBILE PROGRAM WITHIN THE
 15 UNIVERSITY OF MARYLAND SCHOOL OF NURSING.

16 (B) THE PURPOSE OF THE PROGRAM IS TO:

17 (1) DELIVER PRIMARY AND PREVENTIVE HEALTH CARE SERVICES TO
 18 GEOGRAPHICALLY UNDERSERVED COMMUNITIES AND UNINSURED INDIVIDUALS
 19 AROUND THE STATE; AND

20 (2) PROVIDE PRINCIPAL TRAINING SITES FOR THE UNIVERSITY OF
 21 MARYLAND SCHOOL OF NURSING THAT WILL EXPAND STUDENT LEARNING
 22 OPPORTUNITIES IN THE CARE OF UNDERSERVED POPULATIONS.

23 (C) THE PROGRAM SHALL BE OPERATED, MANAGED, AND ADMINISTERED BY
 24 THE UNIVERSITY OF MARYLAND SCHOOL OF NURSING.

25 (D) ~~(1) THE GOVERNOR SHALL INCLUDE IN THE STATE BUDGET, BEGINNING~~
 26 ~~WITH FISCAL YEAR 2002, AT A MINIMUM, SUFFICIENT FUNDS TO OPERATE, MANAGE,~~
 27 ~~AND ADMINISTER THE PROGRAM AS REQUIRED BY THIS SUBSECTION.~~

28 ~~(2) THE FUNDING INCLUDED IN THE STATE BUDGET SHALL BE AT~~

30 ~~(I) \$2.2 MILLION FOR FISCAL YEAR 2002; AND~~

31 ~~(II) \$1.2 MILLION FOR FISCAL YEAR 2003 AND EACH SUBSEQUENT~~

33 ~~(3) FUNDING FOR THE PROGRAM MAY BE PROVIDED THROUGH THE~~

5 (A) (1) THERE IS A GOVERNOR'S WELLMOBILE PROGRAM ADVISORY BOARD.

6 (2) THE PURPOSE OF THE ADVISORY BOARD IS TO ASSIST THE
7 UNIVERSITY OF MARYLAND SCHOOL OF NURSING IN OVERSEEING AND RAISING
8 FUNDS FOR THE PROGRAM.

9 (B) THE ADVISORY BOARD CONSISTS OF NINE INDIVIDUALS, OF WHOM:

10 (1) ONE SHALL BE THE DEAN OF THE UNIVERSITY OF MARYLAND
11 SCHOOL OF NURSING;

12 (2) ONE SHALL BE A MEMBER OF THE HOUSE OF DELEGATES
13 APPOINTED BY THE SPEAKER;

14 (3) ONE SHALL BE A MEMBER OF THE SENATE APPOINTED BY THE
15 PRESIDENT;

16 (4) TWO SHALL HAVE BUSINESS EXPERTISE;

17 (5) TWO SHALL HAVE HEALTH EXPERTISE; AND

18 (6) TWO SHALL HAVE MEDIA OR MARKETING EXPERTISE.

19 (C) EXCEPT FOR THE EX OFFICIO AND LEGISLATIVE MEMBERS, THE
20 MEMBERS OF THE ADVISORY BOARD SHALL BE APPOINTED BY THE GOVERNOR WITH
21 THE ADVICE AND CONSENT OF THE SENATE.

22 (D) THE DEAN OF THE UNIVERSITY OF MARYLAND SCHOOL OF NURSING
23 SHALL SERVE AS THE CHAIRMAN OF THE ADVISORY BOARD.

24 (E) (1) EXCEPT FOR THE EX OFFICIO AND LEGISLATIVE MEMBERS, THE
25 TERM OF A MEMBER IS 3 YEARS.

26 (2) EXCEPT FOR THE EX OFFICIO AND LEGISLATIVE MEMBERS, THE
27 TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR
28 MEMBERS OF THE BOARD ON OCTOBER 1, 2000.

29 (3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL A
30 SUCCESSOR IS APPOINTED.

31 (4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES
32 ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED.

33 (F) THE BOARD SHALL MEET AT LEAST FOUR TIMES EACH YEAR, AT THE
34 TIMES AND PLACES THAT IT DETERMINES.

2 (A) THE UNIVERSITY OF MARYLAND SCHOOL OF NURSING AND THE ADVISORY
3 BOARD SHALL ENSURE THAT THE FOLLOWING GEOGRAPHIC AREAS ARE SERVED BY
4 THE PROGRAM:

- 5 (1) WESTERN MARYLAND;
- 6 (2) THE WASHINGTON METROPOLITAN AREA;
- 7 (3) THE BALTIMORE METROPOLITAN AREA;
- 8 (4) SOUTHERN/CENTRAL MARYLAND;
- 9 (5) THE UPPER EASTERN SHORE; AND
- 10 (6) THE LOWER EASTERN SHORE.

11 (B) THE UNIVERSITY OF MARYLAND SCHOOL OF NURSING AND THE ADVISORY
12 BOARD SHALL:

13 (1) DEVELOP PARTNERSHIPS WITH LOCAL HEALTH DEPARTMENTS,
14 HOSPITALS, SCHOOLS, COMMUNITY ASSOCIATIONS, BUSINESSES, AND OTHER
15 ENTITIES THAT CAN FACILITATE THE PROVISION OF PRIMARY AND PREVENTIVE
16 HEALTH CARE SERVICES THROUGH THE PROGRAM;

17 (2) SOLICIT PUBLIC AND PRIVATE GRANTS AND DONATIONS ON BEHALF
18 OF THE PROGRAM; AND

19 (3) DEVELOP A MECHANISM FOR RECEIVING THIRD PARTY
20 REIMBURSEMENT.

21 (C) THE UNIVERSITY OF MARYLAND, BALTIMORE MAY ESTABLISH A
22 NONPROFIT CORPORATION TO ACCEPT ANY PUBLIC AND PRIVATE GRANTS OR
23 DONATIONS MADE TO THE PROGRAM.

24 (D) (1) ON OR BEFORE SEPTEMBER 1 OF EACH YEAR, THE UNIVERSITY OF
25 MARYLAND SCHOOL OF NURSING AND THE ADVISORY BOARD SHALL SUBMIT A
26 REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE
27 GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY DETAILING THE OPERATION AND
28 MANAGEMENT OF THE PROGRAM, INCLUDING:

29 (I) THE NUMBER OF INDIVIDUALS SERVED BY THE PROGRAM;

30 (II) THE TYPE AND NUMBER OF HEALTH CARE SERVICES PROVIDED
31 TO INDIVIDUALS SERVED BY THE PROGRAM;

32 (III) THE ESTABLISHMENT AND CONTINUATION OF ANY PUBLIC OR
33 PRIVATE PARTNERSHIPS;

1 (IV) THE FUNDING RECEIVED FROM PUBLIC AND PRIVATE
2 SOURCES;

3 (V) FUNDS RECEIVED THROUGH THIRD PARTY REIMBURSEMENT;

4 (VI) THE CONDITION AND MAINTENANCE EXPENSES OF VEHICLES
5 USED BY THE PROGRAM TO DELIVER HEALTH CARE SERVICES;

6 (VII) THE AREAS SERVED BY THE PROGRAM;

7 (VIII) THE IMPACT OF THE PROGRAM IN THE COMMUNITIES SERVED;
8 AND

9 (IX) ANY RECOMMENDATIONS FOR ENHANCING OR FURTHERING
10 THE PURPOSES OF THE PROGRAM.

11 (2) THE OFFICE OF LEGISLATIVE AUDITS SHALL AUDIT THE ACCOUNTS
12 AND TRANSACTIONS OF THE GOVERNOR'S WELLMOBILE PROGRAM ANNUALLY IN
13 ACCORDANCE WITH §§ 2-1220 THROUGH 2-1227 OF THE STATE GOVERNMENT
14 ARTICLE.

15 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
16 members of the Governor's Wellmobile Program advisory board shall expire as
17 follows:

18 (1) Two members in 2001;

19 (2) Two members in 2002; and

20 (3) Two members in 2003.

21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2000.
