1 AN ACT concerning

2 **Home Builder Registration - Application - Social Security Numbers**

3 FOR the purpose of repealing certain provisions of law requiring an applicant for a
4 home builder registration to provide the Social Security number of ~~the applicant~~
5 ~~and~~ all principals of the applicant; making certain technical and conforming
6 corrections; and generally relating to home builder registration applications.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Business Regulation**

15 4.5-303.

16 (a) To apply for registration, an applicant shall:

17 (1) submit to the Unit under oath an application on the form provided by
18 the Unit; and

19 (2) pay [a] THE nonrefundable application fee [established through
20 regulation] REQUIRED BY THIS SUBTITLE.

- 1 (b) The application shall require an applicant to provide:
- 2 (1) the applicant's name;
- 3 (2) the applicant's business address, telephone number, and, if
4 applicable, electronic mail address;
- 5 (3) ~~in~~ in the case of an applicant who is an individual, the applicant's
6 Social Security number;
- 7 (4) in the case of an applicant other than an individual:
- 8 (i) ~~IF THE APPLICANT IS REQUIRED BY LAW TO HAVE A FEDERAL~~
9 ~~EMPLOYER IDENTIFICATION NUMBER~~, the applicant's federal employer identification
10 number; ~~and~~
- 11 (ii) [the names, addresses, and Social Security numbers of all
12 principals of the applicant;]
- 13 ~~(4) THE NAMES AND ADDRESSES OF ALL PRINCIPALS OF THE~~
14 ~~APPLICANT;~~
- 15 (5) the names of all applicants and principals who have previously
16 applied for registration, and the disposition of all previous applications;
- 17 (6) the name of any applicant or principal that was a principal in an
18 entity that previously applied for registration;
- 19 (7) a list of all states and other jurisdictions in which the applicant holds
20 a similar registration or license;
- 21 (8) a list of all states and other jurisdictions in which the applicant has
22 had a similar registration or license suspended or revoked;
- 23 (9) a statement whether any pending judgments or tax liens exist
24 against the applicant;
- 25 (10) (i) the election made by the applicant regarding deposit moneys
26 under § 10-301 of the Real Property Article; and
- 27 (ii) if the applicant elects to hold deposits in an escrow account, the
28 account number and the name of the financial institution that holds the escrow
29 account;
- 30 (11) if the applicant participates in a new home warranty security plan,
31 the name and address of the warranty company; and
- 32 (12) the name of the insurance carrier and the policy number of the
33 general liability coverage required under § 4.5-302 of this subtitle.

2 (a) The Unit shall register and issue a home builder registration number to an
3 applicant that:

4 (2) pays to the Division an initial NONREFUNDABLE 2-year registration
5 fee of \$300.

7 (c) The Unit shall renew the registration of each registrant that:

8 (3) pays to the Division a NONREFUNDABLE renewal fee based on the
9 number of building permits for the construction of new homes issued to the registrant
10 in the preceding calendar year as follows:

11 (i) 10 or fewer new homes \$150; and

12 (ii) 11 or more new homes \$300; and

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2006.
