1 AN ACT concerning

2 **Mental Hygiene Facilities – Patient Rights**

3 FOR the purpose of altering the requirement that individuals in certain facilities be
4 free from certain restraints and seclusions; establishing that individuals in
5 certain facilities be free from certain physical restraints and holds; ~~establishing~~
6 ~~certain rights for individuals in certain State-operated psychiatric facilities;~~
7 ~~providing that the rights established in a certain subtitle may not be limited by~~
8 ~~certain privilege systems; establishing that certain individuals, guardians, and~~
9 ~~persons may file certain complaints in certain courts; requiring that certain~~
10 ~~complainants granted injunctive relief be awarded certain costs and attorney's~~
11 ~~fees~~ providing that a certain requirement does not prohibit a certain action;
12 requiring certain facilities to have a written policy specifying a certain method;
13 requiring certain facilities to ensure that certain staff are trained in the
14 method; and generally relating to patients rights in mental hygiene facilities.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Health - General

10-701.

(a) (1) In this subtitle the following words have the meanings indicated.

(2) "Facility" does not include an acute general care hospital that does not have a separately identified inpatient psychiatric service.

(3) (i) "Mental abuse" means any persistent course of conduct resulting in or maliciously intended to produce emotional harm.

(ii) "Mental abuse" does not include the performance of an accepted clinical procedure.

(b) It is the policy of this State that each mentally ill individual who receives any service in a facility has, in addition to any other rights, the rights provided in this subtitle.

(c) Each individual in a facility shall:

(1) Receive appropriate humane treatment and services in a manner that restricts the individual's personal liberty within a facility only to the extent necessary and consistent with the individual's treatment needs and applicable legal requirements;

(2) Receive treatment in accordance with the applicable individualized plan of rehabilitation or the individualized treatment plan provided for in § 10-706 of this subtitle;

(3) Be free from restraints or [locked door] seclusions except for restraints or [locked door] seclusions that are:

1 (i) [1.] Used only during an emergency [where the individual
2 presents a danger to the life or safety of the individual or of others; or

3 2. Used only to prevent serious disruption to the
4 therapeutic environment] **IN WHICH THE BEHAVIOR OF THE INDIVIDUAL IS**
5 **~~UNANTICIPATED AND~~ PLACES THE INDIVIDUAL OR OTHERS AT SERIOUS THREAT**
6 **OF VIOLENCE OR INJURY;** and

7 (ii) 1. Ordered by a physician in writing; or

8 2. Directed by a registered nurse if a physician's order is
9 obtained within 2 hours of the action;

10 **(4) BE FREE FROM PHYSICAL RESTRAINT OR HOLD THAT:**

11 **(I) PLACES THE INDIVIDUAL FACE DOWN WITH PRESSURE**
12 **APPLIED TO THE BACK;**

13 **(II) OBSTRUCTS THE AIRWAY OF THE INDIVIDUAL OR**
14 **IMPAIRS THE INDIVIDUAL'S ABILITY TO BREATHE;**

15 **(III) OBSTRUCTS A STAFF MEMBER'S VIEW OF THE**
16 **INDIVIDUAL'S FACE; OR**

17 **(IV) RESTRICTS THE INDIVIDUAL'S ABILITY TO**
18 **COMMUNICATE DISTRESS;**

19 **[(4)] (5) Be free from mental abuse; and**

20 **[(5)] (6) Be protected from harm or abuse as provided in this subtitle.**

21 **(D) NOTHING IN SUBSECTION (C)(4) OF THIS SECTION SHALL PROHIBIT**
22 **STAFF FROM USING A TECHNIQUE FOR TRANSITIONING THE INDIVIDUAL TO A**
23 **RESTRAINT POSITION THAT INVOLVES MOMENTARILY:**

24 **(1) PLACING AN INDIVIDUAL FACE DOWN; OR**

25 **(2) OBSTRUCTING THE VIEW OF AN INDIVIDUAL'S FACE.**

26 **(E) A FACILITY SHALL:**

1 **(1) HAVE A WRITTEN POLICY SPECIFYING THE METHOD USED TO**
 2 **ENSURE THAT AN INDIVIDUAL WHOSE PRIMARY LANGUAGE OR METHOD OF**
 3 **COMMUNICATION IS NONVERBAL IS ABLE TO EFFECTIVELY COMMUNICATE**
 4 **DISTRESS DURING A PHYSICAL RESTRAINT OR HOLD; AND**

5 **(2) ENSURE THAT ALL STAFF AT THE FACILITY WHO ARE**
 6 **AUTHORIZED TO PARTICIPATE IN A PHYSICAL RESTRAINT OR HOLD OF**
 7 **INDIVIDUALS ARE TRAINED IN THE METHOD SPECIFIED IN THE WRITTEN POLICY**
 8 **REQUIRED UNDER ITEM (1) OF THIS SUBSECTION.**

9 ~~(d)~~ **(F)** Subject to the provisions of §§ 4–301 through 4–309 of this article,
 10 the records of each individual in a facility are confidential.

11 ~~(e)~~ **(G)** (1) Notwithstanding any other provision of law, when the State
 12 designated protection and advocacy agency for persons with developmental disabilities
 13 has received and documented a request for an investigation of a possible violation of
 14 the rights of an individual in a facility that is owned and operated by the Department
 15 or under contract to the Department to provide mental health services in the
 16 community under this subtitle, the executive director of the protection and advocacy
 17 agency or the executive director's designee:

18 (i) Before pursuing any investigation:

19 1. Shall interview the individual whose rights have been
 20 allegedly violated; and

21 2. Shall attempt to obtain written consent from the
 22 individual; and

23 (ii) If the individual is unable to give written consent but does
 24 not object to the investigation:

25 1. Shall document this fact; and

26 2. Shall request, in writing, access to the individual's
 27 records from the Director of the Mental Hygiene Administration.

28 (2) On receipt of the request for access to the individual's records, the
 29 Director of the Mental Hygiene Administration shall authorize access to the
 30 individual's records.

1 (3) After satisfying the provisions of paragraphs (1) and (2) of this
 2 subsection, the executive director of the protection and advocacy agency, or the
 3 executive director's designee, may pursue an investigation and as part of that
 4 investigation, shall continue to have access to the records of the individual whose
 5 rights have been allegedly violated.

6 ~~(g)~~ **(H)**(1) On admission to a facility, an individual shall be informed of the
 7 rights provided in this subtitle in language and terms that are appropriate to the
 8 individual's condition and ability to understand.

9 (2) A facility shall post notices in locations accessible to the individual
 10 and to visitors describing the rights provided in this subtitle in language and terms
 11 that may be readily understood.

 13 affords an individual the ability to exercise the rights provided in this subtitle.
