CHAPTER _____

1 AN ACT concerning

2 **Campaign Finance – Attribution, Receipt, and Deposit of Contributions**

3 FOR the purpose of providing that certain contributions are attributable to a certain
4 reporting period and election cycle; providing that, for certain purposes, a
5 contribution by electronic transfer or internet transmission is deemed received
6 and deposited when the contribution is issued by the contributor; and generally
7 relating to the attribution, receipt, and deposit of certain contributions.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Election Law**

5 (a) This section applies to the following officials:

6 (1) the Governor;

7 (2) the Lieutenant Governor;

8 (3) the Attorney General;

9 (4) the Comptroller; and

10 (5) a member of the General Assembly.

11 (b) **(1)** Except as provided in subsection (c) or (d) of this section, during a
 12 regular session of the General Assembly an official described in subsection (a) of this
 13 section, or a person acting on behalf of the official, may not, as to a candidate for
 14 federal, State, or local office, or a campaign finance entity of the candidate or any
 15 other campaign finance entity organized under this title and operated in coordination
 16 with a candidate:

17 [(1)] **(I)** receive a contribution;

18 [(2)] **(II)** conduct a fund-raising event;

19 [(3)] **(III)** solicit or sell a ticket to a fund-raising event; or

20 [(4)] **(IV)** deposit or use any contribution of money that was not
 21 deposited prior to the session.

22 **(2) FOR THE PURPOSES OF THIS SUBSECTION, A CONTRIBUTION**
 23 **BY ELECTRONIC TRANSFER OR INTERNET TRANSMISSION IS DEEMED RECEIVED**
 24 **AND DEPOSITED WHEN THE CONTRIBUTION IS ISSUED BY THE CONTRIBUTOR.**

25 (c) An official described in subsection (a) of this section, or a person acting on
 26 behalf of the official, is not subject to this section when engaged in activities solely
 27 related to the official's election to an elective federal or local office for which the official
 28 is a filed candidate.

29 (d) Under the Public Financing Act, a gubernatorial ticket, during the year of
 30 the election only, may accept eligible private contributions and any disbursement of
 31 funds by the State Board that is based on the eligible private contributions.

1 (e) (1) As to a violation of this section, the campaign finance entity of the
2 official in violation is liable for a civil penalty as provided in this subsection.

3 (2) The State Board, represented by the State Prosecutor, may
4 institute a civil action in the circuit court for any county seeking the civil penalty
5 provided in this subsection.

6 (3) A campaign finance entity that receives a contribution as a result
7 of the violation shall:

8 (i) refund the contribution to the contributor; and

9 (ii) pay a civil penalty that equals the sum of \$1,000 plus the
10 amount of the contribution.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2008.
