CHAPTER _____

1 AN ACT concerning

2 **Criminal Procedure – Restitution – Priority to Victims**

3 FOR the purpose of altering a provision of law so as to provide that payment of
4 restitution to a victim has priority over any payments to any other person or
5 governmental unit, subject to certain exceptions; and generally relating to
6 restitution.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Criminal Procedure**

21 11–606.

1 (a) The court may order that restitution be paid to:

2 (1) the victim;

3 (2) the Department of Health and Mental Hygiene, the Criminal
4 Injuries Compensation Board, or any other governmental unit;

5 (3) a third-party payor, including:

6 (i) an insurer; or

7 (ii) any other person that has, under Part I of this subtitle:

8 1. compensated the victim for a property or pecuniary
9 loss; or

10 2. paid an expense on behalf of a victim;

11 (4) any person for whom restitution is authorized by law; or

12 (5) a person who has provided to or for a victim goods, property, or
13 services for which restitution is authorized under § 11-603 of this subtitle.

14 (b) (1) Subject to paragraph (2) of this subsection **AND § 11-617(B) OF**
15 **THIS SUBTITLE**, payment of restitution to the victim has priority over [payment of
16 restitution] **ANY PAYMENTS** to any other person or governmental unit.

17 (2) If the victim has been fully compensated for the victim's loss by a
18 third-party payor, the court may issue a judgment of restitution that directs the
19 restitution obligor to pay restitution to the third-party payor.

21 (b) Subject to federal law, the order of priority of execution of an earnings
22 withholding order is:

23 (1) first, an earnings withholding order issued under § 10-128 of the
24 Family Law Article;

25 (2) second, an earnings withholding order issued under this section;
26 and

27 (3) lastly, any other lien or legal process.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 October 1, 2008.
