A BILL ENTITLED

1 AN ACT concerning

2 **Procurement – Small Business Reserve Program – Eligibility Modifications**

3 FOR the purpose of adding the Maryland Transportation Authority as a designated
4 procurement unit under the Small Business Reserve Program; altering the
5 definition of small business by increasing certain maximum average gross sales
6 requirements and adding a category of services; and generally relating to the
7 Small Business Reserve Program.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – State Finance and Procurement**

16 14–501.

17 (a) In this subtitle the following words have the meanings indicated.

18 (b) “Designated procurement unit” means:

19 (1) the State Treasurer;

20 (2) the Department of Budget and Management;

21 (3) the Department of Business and Economic Development;

21 (c) "Small business" means:

- 22 (1) a certified minority business enterprise, as defined in § 14–301 of
- 23 this title, that meets the criteria specified under paragraph (2) of this subsection; or
- 24 (2) a business, other than a broker, that meets the following criteria:

- 1 (i) the business is independently owned and operated;
- 2 (ii) the business is not a subsidiary of another business;
- 3 (iii) the business is not dominant in its field of operation;
- 4 (iv) the wholesale operations of the business did not employ
5 more than 50 persons, and the gross sales of the business did not exceed an average of
6 [\$2,000,000] **\$4,000,000** in its most recently completed 3 fiscal years;
- 7 (v) the retail operations of the business did not employ more
8 than 25 persons, and the gross sales of the business did not exceed an average of
9 [\$2,000,000] **\$3,000,000** in its most recently completed 3 fiscal years;
- 10 (vi) the manufacturing operations of the business did not employ
11 more than 100 persons, and the gross sales of the business did not exceed an average
12 of \$2,000,000 in its most recently completed 3 fiscal years;
- 13 (vii) the service operations of the business did not employ more
14 than 100 persons, and the gross sales of the business did not exceed an average of
15 [\$2,000,000] **\$10,000,000** in its most recently completed 3 fiscal years; [and]
- 16 (viii) the construction operations of the business did not employ
17 more than 50 persons, and the gross sales of the business did not exceed an average of
18 \$7,000,000 in its most recently completed 3 fiscal years; **AND**
- 19 **(IX) THE ARCHITECTURAL AND ENGINEERING SERVICES OF**
20 **THE BUSINESS DID NOT EMPLOY MORE THAN 100 PERSONS, AND THE GROSS**
21 **SALES OF THE BUSINESS DID NOT EXCEED AN AVERAGE OF \$4,500,000 IN ITS**
22 **MOST RECENTLY COMPLETED 3 FISCAL YEARS.**

23 (d) "Small business reserve" means those procurements that are limited to
24 responses from small businesses under § 14-502(b) of this subtitle.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2008.
