CHAPTER _____

1 AN ACT concerning

2 **Maryland Veterans Behavioral Health**

3 FOR the purpose of establishing behavioral health service coordination among the
4 Department of Health and Mental Hygiene, the United States Department of
5 Veterans Affairs, the Maryland Department of Veterans Affairs, the Maryland
6 National Guard, and the Maryland Defense Force for certain veterans of the
7 Afghanistan or Iraq conflicts; requiring the provision of certain behavioral
8 health services under certain circumstances in certain areas of the State to
9 veterans of the Afghanistan or Iraq conflicts; requiring the Department of
10 Health and Mental Hygiene to seek certain reimbursement for certain services;
11 requiring the Department of Health and Mental Hygiene to separately account
12 for certain funds; creating the Veterans Behavioral Health Advisory Board;

19 Preamble

20 WHEREAS, Maryland has a long and proud history of commitment to military
21 service, with over 460,000 veterans who have served the nation in the armed forces;
22 and

23 WHEREAS, Maryland has over 10,000 veterans of the conflicts in Afghanistan
24 and Iraq, with 5,000 more projected to return by the end of 2008; and

25 WHEREAS, It is among the highest priorities of the State to ensure that
26 veterans returning from active service have the support, opportunities, and services
27 necessary to facilitate their smooth transition from military to civilian life, and to ease
28 that transition for their families; and

29 WHEREAS, Among the obstacles returning veterans often face are unmet
30 physical and behavioral health needs arising out of their service; and

31 WHEREAS, The psychological trauma of the war on terror, the
32 counterinsurgency, and the urban battlefield has put veterans returning from
33 Afghanistan and Iraq at particular risk of Post-Traumatic Stress Syndrome and
34 related conditions, which if untreated can lead to life-long struggles with depression,
35 substance abuse, unemployment, homelessness, and suicide; and

36 WHEREAS, Estimates are that more than half of veterans of the Afghanistan
37 and Iraq conflicts return from combat zones with behavioral health problems that
38 could compromise their successful adjustment to civilian life; and

1 WHEREAS, Gaps in the availability of behavioral health services and
2 impediments to veterans' ability to access those services, particularly in the State's
3 rural areas, may leave serious health problems untreated and exacerbate the
4 difficulties returning veterans and their families must face; and

5 WHEREAS, The State is committed to identifying the behavioral health needs
6 and gaps in services that may exist for returning veterans, and to collaborating with
7 the United States Department of Veterans Affairs, veterans' organizations, and others
8 to address those needs and ensure that veterans and their families receive the services
9 they require and deserve; now, therefore,

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

13 **SUBTITLE 27. BEHAVIORAL HEALTH SERVICES FOR MARYLAND VETERANS OF**

18 (B) "ADJUTANT GENERAL" MEANS THE HEAD OF THE MARYLAND
19 MILITARY DEPARTMENT.

20 (C) "BEHAVIORAL HEALTH SERVICES" MEANS MENTAL HEALTH
21 SERVICES OR ALCOHOL AND SUBSTANCE ABUSE SERVICES.

22 (D) "CRISIS SERVICES" MEANS TEMPORARY SERVICES DESIGNED TO
23 ADDRESS AND STABILIZE A SEVERE BEHAVIORAL HEALTH PROBLEM AND TO
24 AVOID AN EMERGENCY SITUATION, AND MAY INCLUDE HOTLINES, IN-HOME
25 SUPPORT, AND RESIDENTIAL CRISIS SERVICES.

26 (E) "MARYLAND DEFENSE FORCE" MEANS THE MILITARY FORCE
27 ESTABLISHED UNDER § 13-501 OF THE PUBLIC SAFETY ARTICLE.

28 (F) "MARYLAND NATIONAL GUARD" MEANS THE MARYLAND ARMY
29 NATIONAL GUARD AND MARYLAND AIR NATIONAL GUARD.

30 (G) "SERVICE COORDINATION" MEANS A SERVICE DESIGNED TO
31 COORDINATE AND PROVIDE ASSISTANCE IN OBTAINING ACCESS TO BEHAVIORAL
32 HEALTH SERVICES.

1 (H) "SERVICE COORDINATOR" MEANS A PERSON EMPLOYED BY THE
2 DEPARTMENT TO PROVIDE SERVICE COORDINATION TO VETERANS.

3 (I) "UNIFORMED SERVICES" HAS THE MEANING STATED IN 10 U.S.C. §
4 101.

8 DISCHARGED OR RELEASED UNDER CONDITIONS OTHER THAN DISHONORABLE;

11 AS DEFINED IN FEDERAL REGULATIONS, ON OR AFTER OCTOBER 24, 2001, AND

17 STATES SECRETARY OF DEFENSE.

21 INFORMATION, ADVOCACY, AND OTHER RESOURCES REGARDING PUBLIC AND
22 PRIVATE BEHAVIORAL HEALTH SERVICES, CRISIS AND EMERGENCY SERVICES,
23 AND EARLY INTERVENTION AND PREVENTION PROGRAMS; AND

24 (2) ENABLES THE PUBLIC AND PRIVATE HEALTH CARE

31 THE MARYLAND NATIONAL GUARD, AND THE MARYLAND DEFENSE FORCE,

33 REGIONS OF THE STATE TO CONNECT THEM TO BEHAVIORAL HEALTH SERVICES

32 RURAL AREAS OF THE STATE, WHERE EXISTING FEDERAL AND STATE
33 BEHAVIORAL HEALTH SERVICES ARE DETERMINED BY THE DEPARTMENT TO BE
34 INADEQUATE OR INACCESSIBLE.

16 **SERVICES PROVIDED UNDER SUBSECTION (B) OF THIS SECTION.**

25 **(2) ONE MEMBER OF THE SENATE OF MARYLAND, APPOINTED BY**
26 **THE PRESIDENT OF THE SENATE;**

27 **(3) ONE MEMBER OF THE HOUSE OF DELEGATES, APPOINTED BY**
28 **THE SPEAKER OF THE HOUSE;**

1 (4) THE SECRETARY OF THE MARYLAND DEPARTMENT OF
2 VETERANS AFFAIRS, OR THE SECRETARY'S DESIGNEE;

3 (5) THE SECRETARY OF HEALTH AND MENTAL HYGIENE, OR THE
4 SECRETARY'S DESIGNEE;

5 (6) THE ADJUTANT GENERAL, OR THE ADJUTANT GENERAL'S
6 DESIGNEE;

7 (7) A REPRESENTATIVE OF THE UNITED STATES DEPARTMENT
8 OF VETERANS AFFAIRS; AND

9 ~~(7)~~ (8) THE FOLLOWING MEMBERS, APPOINTED BY THE
10 GOVERNOR:

11 (I) ONE REPRESENTATIVE OF A VETERANS SERVICE

19 (C) THE LIEUTENANT GOVERNOR SHALL BE THE CHAIR OF THE

21 (D) THE DEPARTMENTS OF HEALTH AND MENTAL HYGIENE AND
22 VETERANS AFFAIRS SHALL PROVIDE STAFF FOR THE ADVISORY BOARD.

23 (E) A MEMBER OF THE ADVISORY BOARD MAY NOT RECEIVE
24 COMPENSATION AS A MEMBER OF THE ADVISORY BOARD, BUT IS ENTITLED TO
25 REIMBURSEMENT EXPENSES UNDER THE STANDARD STATE TRAVEL
26 REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

27 (F) A MAJORITY OF THE FULL MEMBERSHIP OF THE ADVISORY BOARD
28 SHALL CONSTITUTE A QUORUM.

4 **(2) IDENTIFY THE GAPS IN BEHAVIORAL HEALTH SERVICES**
5 **AVAILABLE TO VETERANS AND THEIR FAMILIES;**

6 **(3) IDENTIFY IMPEDIMENTS TO THE ABILITY OF VETERANS AND**
7 **THEIR FAMILIES TO ACCESS THE BEHAVIORAL HEALTH SERVICES THAT ARE**
8 **AVAILABLE, PARTICULARLY IN THE STATE'S RURAL AREAS;**

9 **(4) FACILITATE COLLABORATION AMONG ORGANIZATIONS AND**
10 **ENTITIES, INCLUDING HOSPITALS, THAT PROVIDE BEHAVIORAL HEALTH**
11 **SERVICES TO VETERANS AND THEIR FAMILIES;**

12 **(5) MAKE RECOMMENDATIONS WITH RESPECT TO IMPROVING**

31 **FINDINGS AND RECOMMENDATIONS ON OR BEFORE DECEMBER 1, 2010, TO THE**
32 **GOVERNOR AND, SUBJECT TO § 2-1246 OF THE STATE GOVERNMENT ARTICLE,**
33 **THE GENERAL ASSEMBLY.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That:

2 (a) On or before September 1, 2008, the Department of Health and Mental
3 Hygiene, in conjunction with the Veterans Behavioral Health Advisory Board
4 established under Section 1 of this Act, shall submit a grant application to the United
5 States Department of Veterans Affairs or other appropriate federal agency for a
6 minimum of \$3,500,000 in federal funds in fiscal year 2010 and a minimum of
7 \$3,500,000 in federal funds in fiscal year 2011 to support the provision of behavioral
8 health services to veterans under this Act.

9 (b) The Department shall send a copy of the application required under this
10 section to the members of the Maryland Congressional Delegation and, in accordance
11 with § 2-1246 of the State Government Article, the Senate Budget and Taxation
12 Committee, the Senate Finance Committee, the House Appropriations Committee, and
13 the House Health and Government Operations Committee.

14 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take
15 effect June 1, 2008. It shall remain effective for a period of 3 years and, at the end of
16 May 31, 2011, with no further action required by the General Assembly, this Act shall
17 be abrogated and of no further force and effect.
