4	FOR the purpose of altering the number of video lottery operation licenses and video

8	conditions; providing that a certain restriction on the number of video lottery
9	operation licenses that may be awarded in a county or Baltimore City is not
10	applicable; providing that a bid for a certain video lottery operation license be
11	made by a certain date; making this Act contingent on the passage and
12	ratification of a certain constitutional amendment; and generally relating to the
13	operation of video lottery terminals at a certain location in the State.

19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

22 23 24	1. build any type of hotel, motel, or other public lodging accommodation on or within 10 miles of the property owned by the holder of the license on which a video lottery facility is operated;
25 26 27	2. convert an existing facility on or within 10 miles of the property described in item 1 of this subparagraph into any type of hotel, motel, or other public lodging accommodation;
28 29 30	3. build or operate a conference center or convention center, amusement park, amusement rides, arcade, or miniature golf course on or within 10 miles of the property described in item 1 of this subparagraph; or

In determining the highest potential revenues to be achieved 5 by additional video lottery terminals at each potential location, the State Lottery 6 Commission shall consider the market performance of the existing video lottery 7 terminals at each location. 8 9 (j) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS 10 **SUBSECTION, A** bid submitted for a video lottery operation license at a video lottery destination location under this section shall be submitted by February 1, 2009, and 11 12 shall include an initial license fee in the bid of at least \$3,000,000 for each 500 video 13 lottery terminals included in the bid. 14 **(2)** A BID SUBMITTED FOR A VIDEO LOTTERY OPERATION 15 **BALTIMORE-WASHINGTON** LICENSE AT INTERNATIONAL THURGOOD 16 MARSHALL AIRPORT SHALL BE SUBMITTED BY APRIL 15, 2011. 17 [(2)] (3) All initial license fees submitted under this subtitle shall the Education Trust Fund established under 18 accrue to Ş 19 9–1A–30 of this subtitle. 20 [(3)] **(4)** A bid submitted for a video lottery operation license under this section shall provide for at least \$25,000,000 in direct investment by the applicant 21 in construction and related costs for each 500 video lottery terminals contained in the 22 proposed bid that shall be prorated based on the exact number of video lottery 23 24terminals contained in the bid. 25 Nothing in this subtitle may be construed to require the Video (p) 26 Lottery Facility Location Commission to issue all [five] SIX video lottery operation 27 licenses authorized under this subtitle. 28 (2)Notwithstanding any of the provisions of this subtitle, the Video 29 Lottery Facility Location Commission may not award a video lottery operation license under this subtitle unless the Video Lottery Facility Location Commission determines 30 31 and declares that a bid selected for award of the license is in the public interest and is 32 consistent with the purposes of this subtitle. SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent on 33 the passage of Chapter (S.B. /H.B.)(9lr2925) of the Acts of the General 34
