AMENDMENTS TO SENATE BILL 314
(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the Finance Committee Amendments (SB0314/537370/1), in line 4 of Amendment No. 1, strike “on-call”.

On page 1 of the bill, in lines 5, 6, 9, 14, and 15, in each instance, strike “on-call”; and in line 7, strike “the on-call” and substitute “certain”.

AMENDMENT NO. 2

On page 3 of the Finance Committee Amendments, after line 7 of Amendment No. 2, insert:

“(H) “HOSPITAL-BASED PHYSICIAN” MEANS A PHYSICIAN WHO:

(1) IS UNDER CONTRACT WITH A HOSPITAL TO PROVIDE HEALTH CARE SERVICES TO PATIENTS IN THE HOSPITAL; AND

(2) IS NOT AN ON-CALL PHYSICIAN.”;

and in lines 8, 10, and 17, strike “**(H)**”, “**(I)**”, and “**(J)**”, respectively, and substitute “**(I)**”, “**(J)**”, and “**(K)**”, respectively.

On page 4 of the Finance Committee Amendments, in lines 4, 7, 13, 18, and 20 of Amendment No. 2, strike “**(K)**”, “**(L)**”, “**(M)**”, “**(N)**”, and “**(O)**”, respectively, and substitute “**(L)**”, “**(M)**”, “**(N)**”, “**(O)**”, and “**(P)**”, respectively.

On page 5 of the Finance Committee Amendments, in lines 4, 6, 10, and 15 of Amendment No. 2, strike “**(P)**”, “**(Q)**”, “**(R)**”, and “**(S)**”, respectively, and substitute “**(Q)**”, “**(R)**”, “**(S)**”, and “**(T)**”, respectively.

On page 6 of the Finance Committee Amendments, in line 19 of Amendment No. 2, after “**PHYSICIAN**” insert “**OR A HOSPITAL-BASED PHYSICIAN**”.

On page 8 of the Finance Committee Amendments, in line 4 of Amendment No. 3, after “**PHYSICIANS**” insert “**OR HOSPITAL-BASED PHYSICIANS**”.

On page 3 of the bill, in line 24, after “**PHYSICIANS**” insert “**AND HOSPITAL-BASED PHYSICIANS**”; and in line 29, strike “**AN ON-CALL**” and substitute “**A**”.

On page 4 of the bill, in lines 2, 7, 9, 12, 13, 19, 23, 26, and 32, in each instance, strike “**ON-CALL**”; in lines 3 and 14, in each instance, strike “**AN ON-CALL**” and substitute “**A**”; and in lines 4, 15, and 30, in each instance, strike “**AN ON-CALL**” and substitute “**A**”.

On page 5 of the bill, in lines 1 and 29, in each instance, strike “**ON-CALL**”; in lines 21 and 26, in each instance, strike “**AN ON-CALL**” and substitute “**A**”; and in line 33, strike “**AN ON-CALL**” and substitute “**A**”.

On page 9 of the bill, in line 9, after “on-call” insert “**and hospital-based**”.
