AMENDMENTS TO SENATE BILL 627, AS AMENDED

(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the Judicial Proceedings Committee Amendments (SB0627/878670/1), in Amendment No. 1, in lines 13 and 18, in each instance, strike “or dispensing centers”; in lines 15 and 16, strike “and dispensing centers”; in line 20, strike “and dispensing centers”; and in line 22, strike “or dispensing center”.

On page 5 of the Judicial Proceedings Committee Amendments, in Amendment No. 4, in lines 6 and 7, strike “DISPENSING CENTER OR”; and in line 12, strike “DISPENSING CENTER OR”.

On page 6 of the Judicial Proceedings Committee Amendments, in line 18 of Amendment No. 5, strike “DISPENSING CENTER OR”.

On page 7 of the Judicial Proceedings Committee Amendments, in line 3 of Amendment No. 5, strike “DISPENSING CENTER OR”.

On page 8 of the Judicial Proceedings Committee Amendments, in lines 5 and 6 of Amendment No. 5, strike “DISPENSING CENTER OR”.

On page 8 of the Judicial Proceedings Committee Amendments, in Amendment No. 6, in line 13, strike “OR A DISPENSING CENTER”; and in lines 13 and 14, strike “OR DISPENSING CENTER”.

On page 9 of the Judicial Proceedings Committee Amendments, in Amendment No. 7, in line 6, strike “OR A DISPENSING CENTER”; in lines 11, 15, and 17, in each instance, strike “OR DISPENSING CENTER”; and in lines 13 and 14, strike “OR DISPENSING CENTER”.

(Over)

On page 10 of the Judicial Proceedings Committee Amendments, in Amendment No. 7, in lines 1 and 5, in each instance, strike “OR DISPENSING CENTER”; and in line 13, strike “AND DISPENSING CENTER”.

On page 11 of the Judicial Proceedings Committee Amendments, in lines 7 and 13 of Amendment No. 7, in each instance, strike “OR DISPENSING CENTER”.

On page 12 of the Judicial Proceedings Committee Amendments, in Amendment No. 7, in line 4, strike “OR DISPENSING CENTER”; and in lines 7 and 8, strike “OR DISPENSING CENTER”.

AMENDMENT NO. 2

On page 2 of the bill, in line 4, strike “and dispensing centers”; in lines 5 and 6, strike “or dispensing center”; in line 8 strike the first comma and substitute “and”; and in the same line, strike “, and dispensing centers”.

On page 3 of the bill, strike in their entirety lines 19 through 22, inclusive; and in lines 23, 25, and 30, strike “**(F)**”, “**(G)**”, and “**(H)**”, respectively, and substitute “**(E)**”, “**(F)**”, and “**(G)**”, respectively.

On page 4 of the bill, in lines 1, 14, 17, 20, and 25, strike “**(I)**”, “**(J)**”, “**(K)**”, “**(L)**”, and “**(M)**”, respectively, and substitute “**(H)**”, “**(I)**”, “**(J)**”, “**(K)**”, and “**(L)**”, respectively.

On page 6 of the bill, strike beginning with the colon in line 16 down through “**A**” in line 17 and substitute “A”; strike beginning with the semicolon in line 18 down through “**SECTION**” in line 20; and in lines 24, 27, and 29, in each instance, strike “**OR DISPENSING CENTER**”.

On page 7 of the bill, in lines 1 and 2, strike “**OR DISPENSING CENTER**”; and in lines 28, 29, 33, and 34, in each instance, strike “**DISPENSING CENTER OR**”.

On page 8 of the bill, in line 2, strike “**DISPENSING CENTER OR**”; and in lines 12 and 13, 13, and 19, in each instance, strike “**OR DISPENSING CENTER**”.

On page 14 of the bill, in lines 17 and 18 and 22 and 23, strike “**OR DISPENSING CENTER**”.

On page 16 of the bill, in line 10, strike “**AND DISPENSING CENTERS**”; and in lines 15 and 16, strike “**OR DISPENSING CENTER**”.
