1 AN ACT concerning

2 **Baltimore City – Park Heights Redevelopment Area – Alcoholic Beverages –**
3 **Store Opening Hours**

4 FOR the purpose of altering the time at which establishments issued certain alcoholic
5 beverages licenses in the Park Heights Redevelopment Area in Baltimore City
6 may begin selling alcoholic beverages; making certain technical corrections; and
7 generally relating to alcoholic beverages licensees in Baltimore City.

8 BY repealing and reenacting, without amendments,

10 Section 8–203(a), (b), and (d)(1), 11–302(b)(1) and (d)(1), and 11–303(d)(1)

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article 2B – Alcoholic Beverages**

5 8–203.

6 (a) The provisions of this section only apply in Baltimore City.

7 (b) In this section, “Board” means the Board of License Commissioners of
8 Baltimore City.

9 (d) (1) There is a Class B–D–7 license.

10 (3) **(I)** [Licensees] **EXCEPT AS PROVIDED IN SUBPARAGRAPH**
11 **(II) OF THIS PARAGRAPH, LICENSEES** may sell all alcoholic beverages at retail at
12 the place in the license described, for consumption on the premises and elsewhere,
13 from 6 a.m. to 2 a.m. on the following day, 7 days per week.

14 **(II) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT**
15 **IS SPECIFIED IN THE PARK HEIGHTS MASTER PLAN ADOPTED IN 2006, THE**
16 **HOURS OF SALE BEGIN AT 9 A.M. EACH DAY.**

17 11–302.

18 (a) (1) The hours during which the privileges conferred by a Class A beer
19 and light wine license may be exercised are from 6 a.m. to midnight on every day
20 except Sunday.

21 **(2) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT IS**
22 **SPECIFIED IN THE PARK HEIGHTS MASTER PLAN ADOPTED BY BALTIMORE**
23 **CITY IN 2006, THE HOURS OF SALE BEGIN AT 9 A.M. EACH DAY.**

24 **[(2)] (3)** In Frederick County, on Sunday the hours are from 1 p.m. to
25 midnight.

26 **[(3)] (4)** In Montgomery County the hours are as provided in §
27 11–516(d)(1).

28 **[(4)] (5)** In Prince George’s County the hours are from 6 a.m. to 2
29 a.m. on the following day except on Sunday when sales are not permitted after 2 a.m.

30 (b) (1) The hours during which the privileges conferred by a Class B beer
31 and light wine license may be exercised are from 6 a.m. to midnight.

1 (2) Except as otherwise provided in subsections (h) [and], (i), AND (J)
2 of this section, in Baltimore City the hours are from 6 a.m. to 2 a.m. on the following
3 day.

4 (d) (1) The hours during which the privileges conferred by a Class D beer
5 and light wine license may be exercised are from 6 a.m. to midnight.

6 (2) Except as otherwise provided in subsections (h) [and], (i), AND (J)
7 of this section, in Baltimore City the hours are from 6 a.m. to 1 a.m. on the following
8 day.

9 **(J) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT IS SPECIFIED**
10 **IN THE PARK HEIGHTS MASTER PLAN ADOPTED BY BALTIMORE CITY IN 2006,**
11 **THE HOURS OF SALE BEGIN AT 9 A.M. EACH DAY.**

12 [(j)] **(K)** In Carroll County, the privileges conferred by a Class A beer and
13 light wine license may be exercised from 11 a.m. to 6 p.m. on Sundays.

14 11-303.

15 (a) (1) The hours during which the privileges conferred by a Class A beer,
16 wine and liquor license may be exercised are from 6 a.m. to midnight, on every day
17 except Sunday.

18 (2) The provisions of paragraph (1) of this subsection are superseded
19 as follows:

20 (i) In Annapolis, the hours may be fixed by the Mayor,
21 Counselor, and Aldermen of the City of Annapolis;

22 **(II) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT**
23 **IS SPECIFIED IN THE PARK HEIGHTS MASTER PLAN ADOPTED BY BALTIMORE**
24 **CITY IN 2006, THE HOURS OF SALE BEGIN AT 9 A.M. EACH DAY;**

25 [(ii)] **(III)** In Carroll County, the privileges conferred by a Class
26 A beer, wine and liquor license may be exercised from 11 a.m. to 6 p.m. on Sunday;

27 [(iii)] **(IV)** In Frederick County, holders of a Class A beer, wine
28 and liquor (off-sale) license may sell beer, wine and liquor for off-premises
29 consumption on Sundays from 1 p.m. to midnight if they hold a special Sunday
30 opening permit;

31 [(iv)] **(V)** In Kent County, the provisions of § 11-515 of this
32 article apply;

1 ~~[(v)] (VI)~~ In St. Mary's County, holders of a Class A-1 license
2 may sell on Sunday; and

3 ~~[(vi)] (VII)~~ In Talbot County, the hours are from 8 a.m. to 12
4 midnight.

5 (b) (1) The hours during which the privileges conferred by a Class B beer,
6 wine and liquor license may be exercised are from 6 a.m. to 2 a.m. on the following
7 day.

8 (2) In Annapolis, the hours shall be as fixed by the Mayor, Counselor,
9 and Aldermen of the City of Annapolis.

10 (3) In Montgomery County, except as provided in § 11-516 of this
11 article, the hours are from 9 a.m. on any day to 1 a.m. on the following day.

12 (4) In the 47th alcoholic beverages district in Baltimore City, the
13 hours for off-sales under a Class B beer, wine and liquor license for use in a
14 restaurant are as provided for in § 6-201(d) of this article.

15 **(5) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT IS**
16 **SPECIFIED IN THE PARK HEIGHTS MASTER PLAN ADOPTED BY BALTIMORE**
17 **CITY IN 2006, THE HOURS OF SALE BEGIN AT 9 A.M. EACH DAY.**

18 (d) (1) The hours during which the privileges conferred by a Class D beer,
19 wine and liquor license may be exercised are from 6 a.m. to midnight.

20 (2) Except as otherwise provided in subsections (e) [and], (f), AND (G)
21 of this section, in Baltimore City the hours are from 6 a.m. to 1 a.m.

22 **(G) IN THE PARK HEIGHTS REDEVELOPMENT AREA THAT IS SPECIFIED**
23 **IN THE PARK HEIGHTS MASTER PLAN ADOPTED BY BALTIMORE CITY IN 2006,**
24 **THE HOURS OF SALE BEGIN AT 9 A.M. EACH DAY.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 June 1, 2010.
