CHAPTER _____

1 AN ACT concerning

2 **Electricians, Gas Fitters, HVAC Contractors, and Plumbers – Display of**
3 **Licenses and License Numbers**

4 FOR the purpose of prohibiting a county or municipal corporation, subject to a certain
5 exception, from requiring a certain licensed gas fitter, plumber, or heating,
6 ventilation, air-conditioning, and refrigeration (HVAC) contractor to display a
7 certain certificate number on certain vehicles used for providing certain
8 services; prohibiting a county or municipal corporation, subject to certain
9 exceptions, from requiring a certain licensed master electrician to display a
10 certain license number on certain vehicles used for providing certain services;
11 requiring a master electrician who holds a certain license or certain licenses to
12 display a State license number on certain vehicles used for providing certain
13 services; and generally relating to the display of licenses and license numbers
14 on vehicles.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article – Business Occupations and Professions**

5 6–301.

6 (a) Each county shall:

7 (1) adopt regulations that have qualifications comparable to § 6–304,
8 to provide for the licensing and regulation of master electricians; or

9 (2) (i) require a State license for providing electrical services as a
10 master electrician; and

11 (ii) enforce the provisions of this title.

12 (b) Each municipal corporation shall:

13 (1) adopt regulations that have qualifications comparable to, or more
14 stringent than, § 6–304 of this subtitle to provide for the licensing and regulation of
15 master electricians;

16 (2) adopt the electrical rules and regulations of the county in which
17 the municipal corporation is located; or

18 (3) (i) require a State license for providing electrical services as a
19 master electrician; and

20 (ii) enforce the provisions of this title.

21 **(C) A COUNTY OR MUNICIPAL CORPORATION MAY NOT ADOPT A**
22 **REGULATION OR ENACT A LAW THAT REQUIRES A PERSON LICENSED UNDER**
23 **THIS SUBTITLE TO DISPLAY A LICENSE NUMBER ON EACH VEHICLE USED ON**
24 **THE JOB FOR PROVIDING ELECTRICAL SERVICES.**

25 **(D) EACH LICENSED MASTER ELECTRICIAN SHALL DISPLAY THE STATE**
26 **LICENSE NUMBER OR THE COUNTY LICENSE NUMBER OF THE LICENSEE ON**
27 **EACH VEHICLE USED ON THE JOB FOR PROVIDING ELECTRICAL SERVICES.**

29 (a) (1) Each master plumber shall display:

1 (i) the master plumber license and the license number
2 conspicuously in the principal place of business of the master plumber; and

3 (ii) the license number of the master plumber license on each
4 vehicle used on the job for providing plumbing services.

5 (2) Each holder of a limited master plumber license shall display:

6 (i) the limited master plumber license and the license number
7 conspicuously in the principal place of business of the holder of the limited master
8 plumber license; and

9 (ii) the license number of the limited master plumber license on
10 each vehicle used on the job for providing plumbing services.

11 (3) Each holder of a propane gas fitter certificate shall display:

12 (i) the propane gas fitter certificate and the certificate number
13 conspicuously in the principal place of business of the certificate holder; and

14 (ii) the certificate number of the propane gas fitter certification
15 on each vehicle used on the job in providing propane gas services.

16 (4) Each holder of a master natural gas fitters license shall display:

17 (i) the master natural gas fitters license and the license
18 number conspicuously in the principal place of business of the license holder; and

19 (ii) the license number of the master natural gas fitters license
20 on each vehicle used on the job for providing natural gas services.

21 **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
22 **SUBSECTION, A COUNTY OR MUNICIPAL CORPORATION MAY NOT REQUIRE A**
23 **PERSON LICENSED UNDER THIS SUBTITLE TO DISPLAY A COUNTY OR MUNICIPAL**
24 **CORPORATION CERTIFICATE NUMBER ON EACH VEHICLE USED ON THE JOB FOR**
25 **PROVIDING PLUMBING, NATURAL GAS FITTING, OR PROPANE GAS FITTING**
26 **SERVICES.**

27 **(2) THIS SUBSECTION DOES NOT APPLY TO BALTIMORE COUNTY**
28 **OR THE AREAS IN THE STATE UNDER THE JURISDICTION OF THE WASHINGTON**
29 **SUBURBAN SANITARY COMMISSION.**

30 **[(b)] (C)** Each licensee shall give the Board and any appropriate licensing
31 authority written notice of any change of name, address, or employment from that
32 which appears on the current license, at least 10 working days before the change is to
33 take effect.

1 **Article – Business Regulation**

2 9A-401.

3 (a) Each licensed master, master restricted, or limited heating, ventilation,
4 air-conditioning, and refrigeration contractor shall display:

5 (1) the license and the license number conspicuously in the principal
6 place of business of the licensee; and

7 (2) the license number of the licensee on each vehicle used on the job
8 for providing heating, ventilation, air-conditioning, or refrigeration services.

9 **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
10 **SUBSECTION, A COUNTY OR MUNICIPAL CORPORATION MAY NOT REQUIRE A**
11 **PERSON LICENSED UNDER THIS SUBTITLE TO DISPLAY A COUNTY OR MUNICIPAL**
12 **CORPORATION CERTIFICATE NUMBER ON EACH VEHICLE USED ON THE JOB FOR**
13 **PROVIDING HEATING, VENTILATION, AIR-CONDITIONING, AND REFRIGERATION**
14 **SERVICES.**

15 **(2) THIS SUBSECTION DOES NOT APPLY TO ANNE ARUNDEL**
16 **COUNTY.**

17 **[(b)] (C)** Each licensee shall give the Board written notice of any change of
18 name, address, or employment from that which appears on the current license, at least
19 10 working days before the change is to take effect.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2010.
