CHAPTER _____

1 AN ACT concerning

2 **Maryland Statutory Trust Act**

3 FOR the purpose of clarifying and revising the Maryland Business Trust Act and
4 renaming it to be the Maryland Statutory Trust Act; providing that a use of a
5 certain designation or statement in a certain certificate of trust or governing
6 instrument does not create a certain presumption or inference; providing for the
7 construction of certain provisions of this Act; clarifying that a statutory trust
8 has certain general powers under certain circumstances; clarifying the
9 requirements for, and time at which, a statutory trust is formed; providing for
10 the restatement of a certificate of trust under certain circumstances; providing
11 for the execution and effective time of certain documents; clarifying that a
12 governing instrument of a statutory trust may contain certain provisions
13 relating to the nature and division of beneficial interests in the statutory trust,
14 the rights of certain persons, amendments to the governing instrument, and
15 actions by or on behalf of the statutory trust in the event there are no trustees;
16 clarifying that a statutory trust is not required to execute its governing
17 instrument and that it is bound by its governing instrument; clarifying that a
18 beneficial owner or trustee of a statutory trust is bound by the statutory trust's
19 governing instrument; clarifying the types of consideration that may be
20 contributed for a beneficial interest in a statutory trust; clarifying and altering
21 the powers of a statutory trust to indemnify and hold harmless, and to pay or
22 reimburse certain expenses incurred by, certain persons; altering the
23 circumstances under which certain records of a statutory trust may be inspected
24 and copied; clarifying that, except as provided in the governing instrument of a
25 statutory trust, meetings of beneficial owners or trustees may be held in a

1 certain manner, beneficial owners or trustees may vote or consent to a certain
2 action in a certain manner, and certain actions must be approved by the
3 beneficial owners or trustees by a certain percentage of votes; clarifying certain
4 powers, duties, and liabilities of the trustees of a statutory trust; providing that
5 a governing instrument may not eliminate the duty of a trustee to perform the
6 trustee's duties in good faith; providing for certain limits on the duties of a
7 trustee; providing that no creditor of a trustee shall have the right to exercise
8 any legal or equitable remedy with respect to certain property under certain
9 circumstances; providing that a trustee of a certain statutory trust shall be
10 deemed to be independent and disinterested when making a certain
11 determination or taking certain action; providing that certain persons, in the
12 governing instrument of a statutory trust or other writing, may consent to be
13 subject to certain jurisdiction or arbitration and to be served with legal process
14 in a certain manner; altering the vote by which the trustees of a statutory trust
15 must approve a merger or consolidation; altering certain requirements for
16 articles of merger or consolidation; establishing that, subject to the Maryland
17 Constitution, certain laws govern the organization, internal affairs, and liability
18 of the trustees of a foreign statutory trust, and a foreign statutory trust may not
19 be denied registration under certain circumstances; requiring a foreign
20 statutory trust to register with the State Department of Assessments and
21 Taxation before doing certain business in the State; establishing certain
22 requirements for registration; prohibiting a foreign statutory trust from doing
23 any kind of business in the State that a domestic statutory trust is prohibited
24 from doing under the laws of the State; authorizing a foreign statutory trust to
25 cancel its registration in a certain manner; establishing certain penalties for
26 failing to register with the Department and for transacting certain business on
27 behalf of a foreign statutory trust that has not registered with the Department;
28 authorizing the Attorney General to bring a certain action; specifying certain
29 actions that do and do not constitute doing business in the State; providing that
30 by doing certain business in the State a foreign statutory trust assents to the

33 State; defining certain terms; altering and repealing certain definitions; making
34 certain conforming and stylistic changes; and generally relating to statutory

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
27 MARYLAND, That the Laws of Maryland read as follows:

28 **Article – Corporations and Associations**

29 Title 12. [Business] **STATUTORY** Trusts.

30 12–101.

31 (a) In this title the following words have the meanings indicated.

32 (b) “Beneficial owner” means any owner **OF RECORD** of a beneficial interest
33 in a [business] **STATUTORY** trust, the fact of ownership to be determined and
34 evidenced, whether by means of registration, the issuance of certificates or otherwise,
35 in conformity to the applicable provisions of the governing instrument of the
36 [business] **STATUTORY** trust.

1 [(c) (1) “Business trust” means an unincorporated business, trust, or
2 association that:

3 (i) Is created by a governing instrument under which:

4 1. Property is or will be held, managed, administered,
5 controlled, invested, reinvested, or operated by a trustee for the benefit of persons as
6 are or may become entitled to a beneficial interest in the trust property; or

7 2. Business or professional activities for profit are
8 carried on or will be carried on by a trustee for the benefit of persons as are or may
9 become entitled to a beneficial interest in the trust property; and

10 (ii) Files a certificate of trust under § 12–204 of this title.

11 (2) “Business trust” includes:

12 (i) A trust of the type known at common law as a “business
13 trust” or “Massachusetts trust”; or

14 (ii) A trust qualifying as a real estate mortgage investment
15 conduit under Section 860D of the United States Internal Revenue Code of 1986, as
16 amended, or under any successor provision.

17 (3) “Business trust” does not include a trust organized as a real estate
18 investment trust under Title 8 of this article.

19 (d) “Foreign limited liability company” has the meaning stated in § 4A–101(j)
20 of this article.

21 (e) “Foreign limited partnership” has the meaning stated in § 10–101(f) of
22 this article.]

23 **(C) “FOREIGN BUSINESS ENTITY” MEANS:**

24 **(1) A FOREIGN STATUTORY TRUST; OR**

25 **(2) A CORPORATION, GENERAL OR LIMITED PARTNERSHIP,**
26 **COMMON–LAW TRUST, LIMITED LIABILITY COMPANY, REAL ESTATE**
27 **INVESTMENT TRUST, LIMITED LIABILITY COMPANY, OR ANY OTHER**
28 **UNINCORPORATED BUSINESS FORMED, ORGANIZED, OR EXISTING UNDER THE**
29 **LAWS OF ANOTHER STATE, THE UNITED STATES, A FOREIGN COUNTRY, OR**
30 **OTHER FOREIGN JURISDICTION.**

31 **(D) “FOREIGN STATUTORY TRUST” MEANS A TRUST THAT IS:**

1 **(1) FORMED UNDER THE LAWS OF ANOTHER STATE, THE UNITED**
2 **STATES, A FOREIGN COUNTRY, OR OTHER FOREIGN JURISDICTION; AND**

3 **(2) REQUIRED BY THE LAWS OF THE JURISDICTION IN WHICH IT**
4 **IS FORMED TO FILE A RECORD WITH A PUBLIC OFFICIAL IN THAT JURISDICTION.**

5 **[(f)] (E)** “Governing instrument” means a **DECLARATION OF TRUST OR**
6 **OTHER** trust instrument which [creates a business trust and] provides for the
7 governance of the affairs of [the business] **A STATUTORY** trust and the conduct of its
8 business.

9 **[(g)] (F)** (1) “Other business entity” means a corporation, a general or
10 limited partnership, a common-law trust, a limited liability company, a real estate
11 investment trust [or corporation], or any other unincorporated business.

12 (2) “Other business entity” does not include a [business] **STATUTORY**
13 trust.

14 **[(h)] (G)** “Person” means a natural person, partnership, limited partnership,
15 limited liability company, trust, estate, association, corporation, custodian, nominee,
16 or any other individual or entity in its own or any representative capacity.

17 **(H) (1) “STATUTORY TRUST” MEANS AN UNINCORPORATED**
18 **BUSINESS, TRUST, OR ASSOCIATION THAT IS:**

19 **(I) FORMED BY FILING AN INITIAL CERTIFICATE OF TRUST**
20 **UNDER § 12-204 OF THIS TITLE; AND**

21 **(II) GOVERNED BY A GOVERNING INSTRUMENT.**

22 **(2) “STATUTORY TRUST” INCLUDES A TRUST FORMED UNDER**
23 **THIS TITLE ON OR BEFORE MAY 31, 2010, AS A BUSINESS TRUST, AS THE TERM**
24 **BUSINESS TRUST WAS THEN DEFINED IN THIS TITLE.**

25 (i) (1) “Trustee” means the person appointed as a trustee in accordance
26 with the governing instrument of a [business] **STATUTORY** trust.

27 (2) “Trustee” may include a beneficial owner of a [business]
28 **STATUTORY** trust.

30 **THE USE OF THE DESIGNATION “BUSINESS TRUST” OR A STATEMENT IN A**
31 **CERTIFICATE OF TRUST OR GOVERNING INSTRUMENT EXECUTED ON OR BEFORE**
32 **MAY 31, 2010, TO THE EFFECT THAT A TRUST IS OR WILL QUALIFY AS A**

1 **MARYLAND BUSINESS TRUST WITHIN THE MEANING OF OR IN ACCORDANCE**
2 **WITH THIS TITLE MAY NOT CREATE A PRESUMPTION OR AN INFERENCE THAT**
3 **THE TRUST IS A BUSINESS TRUST FOR PURPOSES OF TITLE 11 OF THE UNITED**

6 (a) Except [to the extent otherwise] AS provided in the governing instrument
7 of a [business] STATUTORY trust or in this title, the laws of this State pertaining to
8 trusts are hereby made applicable to [business] STATUTORY trusts.

9 (b) For purposes of any tax imposed by the Tax – General Article, a
10 [business] STATUTORY trust shall be classified as a corporation, an association, a
11 partnership, a trust, or otherwise, as shall be determined under the United States
12 Internal Revenue Code of 1986, as amended, or under any successor provision.

13 (c) Any [business] STATUTORY trust qualifying as a real estate mortgage
14 investment conduit under [Section] § 860D of the Internal Revenue Code or any
15 successor provision shall be exempt from income tax except **WITH RESPECT TO** that
16 portion of its income that is subject to federal income tax.

24 **EFFECT TO THE PRINCIPLE OF FREEDOM OF CONTRACT AND TO THE**
25 **ENFORCEABILITY OF GOVERNING INSTRUMENTS.**

26 **(B) THE PRESUMPTION THAT A CIVIL STATUTE IN DEROGATION OF THE**
27 **COMMON LAW IS CONSTRUED STRICTLY DOES NOT APPLY TO THIS TITLE.**

29 (a) Except as provided in subsection (b) of this section, a [business]
30 STATUTORY trust may carry on any lawful business for any purposes.

31 (b) A [business] STATUTORY trust may not carry on the business of:

- 1 (1) Granting policies of insurance or assuming insurance risks; or
2 (2) Banking.

3 **(C) EXCEPT AS PROVIDED IN ITS CERTIFICATE OF TRUST OR**
4 **GOVERNING INSTRUMENT, A STATUTORY TRUST HAS THE GENERAL POWERS,**
5 **WHETHER OR NOT THE GENERAL POWERS ARE SET FORTH IN ITS CERTIFICATE**
6 **OF TRUST OR GOVERNING INSTRUMENT, TO:**

7 **(1) SUE, BE SUED, COMPLAIN, AND DEFEND IN ALL COURTS;**

8 **(2) HAVE, USE, ALTER, OR ABANDON A TRUST SEAL;**

9 **(3) TRANSACT ITS BUSINESS, CARRY ON ITS OPERATIONS, AND**
10 **EXERCISE THE POWERS GRANTED BY THIS ARTICLE IN ANY STATE, TERRITORY,**
11 **DISTRICT, AND POSSESSION OF THE UNITED STATES AND IN ANY FOREIGN**
12 **COUNTRY;**

13 **(4) MAKE CONTRACTS AND GUARANTEES, INCUR LIABILITIES,**
14 **AND BORROW MONEY;**

15 **(5) SELL, LEASE, EXCHANGE, TRANSFER, CONVEY, MORTGAGE,**
16 **PLEDGE, AND OTHERWISE DISPOSE OF ANY OR ALL OF ITS ASSETS;**

17 **(6) ISSUE BONDS, NOTES, AND OTHER OBLIGATIONS AND SECURE**
18 **THE OBLIGATIONS BY MORTGAGE OR DEED OF TRUST OF ANY OR ALL OF ITS**
19 **ASSETS;**

20 **(7) ACQUIRE BY PURCHASE OR IN ANY OTHER MANNER, AND**
21 **TAKE, RECEIVE, OWN, HOLD, USE, EMPLOY, IMPROVE, AND OTHERWISE DEAL**
22 **WITH ANY INTEREST IN REAL OR PERSONAL PROPERTY, WHEREVER LOCATED;**

23 **(8) PURCHASE, TAKE, RECEIVE, SUBSCRIBE FOR, OR OTHERWISE**
24 **ACQUIRE, OWN, HOLD, VOTE, USE, EMPLOY, SELL, MORTGAGE, LOAN, PLEDGE,**
25 **OR OTHERWISE DISPOSE OF AND OTHERWISE USE AND DEAL IN AND WITH**
26 **STOCK AND OTHER INTERESTS IN AND OBLIGATIONS OF OTHER BUSINESS**
27 **ENTITIES, OTHER STATUTORY TRUSTS, AND INDIVIDUALS;**

28 **(9) ACQUIRE ITS OWN SHARES OF BENEFICIAL INTEREST, BONDS,**
29 **NOTES, AND OTHER OBLIGATIONS AND SECURITIES;**

30 **(10) INVEST ITS SURPLUS FUNDS, LEND MONEY FROM TIME TO**
31 **TIME IN ANY MANNER THAT MAY BE APPROPRIATE TO ENABLE THE STATUTORY**

1 TRUST TO CARRY ON ITS OPERATIONS OR FULFILL THE PURPOSES SPECIFIED IN
2 ITS GOVERNING INSTRUMENT, AND TAKE AND HOLD REAL AND PERSONAL
3 PROPERTY AS SECURITY FOR THE PAYMENT OF FUNDS SO INVESTED OR
4 LOANED;

5 (11) BE A PROMOTER, A PARTNER, A MEMBER, AN ASSOCIATE, OR
6 A MANAGER OF ANY PARTNERSHIP, JOINT VENTURE, TRUST, OR OTHER
7 ENTERPRISE;

8 (12) MAKE GIFTS OR CONTRIBUTIONS IN CASH, OTHER PROPERTY,
9 OR STOCK OR OTHER SECURITIES OF THE STATUTORY TRUST TO OR FOR THE
10 USE OF:

11 (I) THE UNITED STATES, THIS STATE, ANOTHER STATE OF
12 THE UNITED STATES, A TERRITORY, POSSESSION, OR DISTRICT OF THE UNITED
13 STATES, OR ANY INSTITUTION, AGENCY, OR POLITICAL SUBDIVISION OF ANY OF
14 THEM; AND

15 (II) ANY GOVERNMENTAL OR OTHER ORGANIZATION,
16 WHETHER INSIDE OR OUTSIDE THE UNITED STATES, FOR RELIGIOUS,
17 CHARITABLE, SCIENTIFIC, CIVIC, PUBLIC WELFARE, LITERARY, OR
18 EDUCATIONAL PURPOSES;

19 (13) ELECT ITS OFFICERS AND APPOINT ITS AGENTS, DEFINE
20 THEIR DUTIES, DETERMINE THEIR COMPENSATION, AND ADOPT AND CARRY
21 INTO EFFECT EMPLOYEE AND OFFICER BENEFIT PLANS;

22 (14) EXERCISE GENERALLY THE POWERS SET FORTH IN ITS
23 GOVERNING INSTRUMENT AND THOSE GRANTED BY LAW; AND

24 (15) DO EVERY OTHER ACT NOT INCONSISTENT WITH LAW WHICH
25 IS APPROPRIATE TO PROMOTE AND ATTAIN THE PURPOSES SET FORTH IN ITS
26 GOVERNING INSTRUMENT.

27 12-202.

28 (a) Except [to the extent otherwise] AS provided in [the] ITS governing
29 instrument [of the business trust, a business], A STATUTORY trust:

30 (1) Shall have perpetual existence; and

31 (2) May not be terminated or revoked by a beneficial owner or other
32 person except in accordance with the terms of the governing instrument of the
33 [business] STATUTORY trust.

1 (b) Except [to the extent otherwise] AS provided in the governing instrument
2 of a [business] STATUTORY trust, the death, incapacity, dissolution, termination, or
3 bankruptcy of a beneficial owner shall not result in the termination or dissolution of a
4 [business] STATUTORY trust.

5 [(c) In the event that a business trust does not have perpetual existence, a
6 business trust is dissolved and its affairs shall be wound up at the time or on the
7 happening of events specified in the governing instrument.

8 (d) On dissolution of a business trust and until the filing of a certificate of
9 cancellation as provided in § 12-204(d) of this subtitle, the persons who, under the
10 governing instrument of the business trust, are responsible for winding up the
11 business trust's affairs may, in the name of and for and on behalf of the business trust,
12 prosecute and defend suits, whether civil, criminal, or administrative, gradually settle
13 and close the business trust business, dispose of and convey the business trust
14 property, discharge or make reasonable provision for the business trust liabilities, and
15 distribute to the beneficial owners any remaining assets of the business trust.

16 (e) (1) A business trust which has dissolved shall pay or make reasonable
17 provision to pay all claims and obligations, including all contingent, conditional, or
18 unmatured claims and obligations, known to the business trust and all claims and
19 obligations which are known to the business trust but for which the identity of the
20 claimant is unknown.

21 (2) If there are sufficient assets, such claims and obligations shall be
22 paid in full and any such provision for payment shall be made in full.

23 (3) If there are insufficient assets, such claims and obligations shall be
24 paid or provided for according to their priority and, among claims and obligations of
25 equal priority, ratably to the extent of assets available.

26 (4) Unless otherwise provided in the governing instrument of a
27 business trust, any remaining assets shall be distributed to the beneficial owners.

28 (5) Any person, including any trustee, who under the governing
29 instrument of the business trust is responsible for winding up a business trust's affairs
30 who has complied with this subsection is not personally liable to the claimants of the
31 dissolved business trust by reason of such person's actions in winding up the business
32 trust.]

34 (a) A Maryland [business] STATUTORY trust shall have:

35 (1) A principal office in this State; and

- 1 (2) At least one resident agent who [shall be] IS:
