A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Criminal Injuries Compensation Board – Claimant**
3 **Confidentiality and Eligibility**

4 FOR the purpose of prohibiting the disclosure of the identity or contact information of
5 a certain victim or claimant by the Criminal Injuries Compensation Board;
6 prohibiting a person who has been convicted of certain offenses from receiving a
7 certain award from the Board; and generally relating to the Criminal Injuries
8 Compensation Board.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Criminal Procedure**

17 11–806.

18 (a) Except as provided under [subsection (b)] **SUBSECTIONS (B) AND (C)** of
19 this section, the record of a proceeding before the Board or a Board member is a public
20 record.

21 (b) If the confidentiality of a record or report that the Board obtains is
22 protected by law or regulation, the record or report shall remain confidential, subject
23 to the law or regulation.

1 **(C) THE BOARD MAY NOT ALLOW THE INSPECTION, USE, OR**
2 **DISCLOSURE OF A NAME, ADDRESS, TELEPHONE NUMBER, OR SOCIAL SECURITY**
3 **NUMBER PROVIDED TO THE BOARD FOR A VICTIM OR A CLAIMANT WHO IS A**
4 **VICTIM OF A SEXUAL OFFENSE UNDER TITLE 3, SUBTITLE 3 OF THE CRIMINAL**
5 **LAW ARTICLE.**

7 (a) (1) Except as provided in paragraph (2) of this subsection, the
8 following persons are eligible for awards in the manner provided under this subtitle:

9 (i) a victim;

10 (ii) a dependent of a victim who died as a direct result of:

11 1. a crime or delinquent act;

12 2. trying to prevent a crime or delinquent act or an
13 attempted crime or delinquent act from occurring in the victim's presence or trying to
14 apprehend a person who had committed a crime or delinquent act in the victim's
15 presence or had committed a felony or a delinquent act that would be considered a
16 felony if committed by an adult; or

17 3. helping a law enforcement officer perform the officer's
18 duties or helping a member of a fire department who is obstructed from performing
19 the member's duties;

20 (iii) any person who paid or assumed responsibility for the
21 funeral expenses of a victim who died as a direct result of:

22 1. a crime or delinquent act;

23 2. trying to prevent a crime or delinquent act or an
24 attempted crime or delinquent act from occurring in the victim's presence or trying to
25 apprehend a person who had committed a crime or delinquent act in the victim's
26 presence or had committed a felony; or

27 3. helping a law enforcement officer perform the officer's
28 duties or helping a member of a fire department who is obstructed from performing
29 the member's duties; and

30 (iv) 1. a parent, child, or spouse of a victim who resides with
31 the victim; or

32 2. a parent, child, or spouse of an individual who is
33 incarcerated for abuse as defined in § 4-501 of the Family Law Article and who, prior
34 to incarceration:

- 1 A. resided with the parent, child, or spouse; and
2 B. provided financial support to the parent, child, or
3 spouse.

4 (2) **[A] THE FOLLOWING PERSONS ARE NOT ELIGIBLE FOR AN**
5 **AWARD UNDER THIS SUBTITLE:**

6 **(I)** A person who commits the crime or delinquent act that is
7 the basis of a claim, or an accomplice of the person[, is not eligible to receive an
8 award] with respect to [the] **THAT** claim; **AND**

9 **(II)** **A PERSON WHO HAS EVER BEEN CONVICTED OF:**

10 1. **MURDER OR ATTEMPTED MURDER UNDER §**
11 **2-201, § 2-204, § 2-205, OR § 2-206 OF THE CRIMINAL LAW ARTICLE;**

12 2. **ATTEMPTED POISONING UNDER § 3-213 OF THE**
13 **CRIMINAL LAW ARTICLE;**

14 3. **CONTAMINATING A WATER SUPPLY OR FOOD OR**
15 **DRINK UNDER § 3-214 OF THE CRIMINAL LAW ARTICLE;**

16 4. **A SEXUAL OFFENSE UNDER § 3-303, § 3-304, §**
17 **3-305, § 3-306, § 3-307, § 3-309, § 3-310, § 3-311, § 3-312, § 3-315, § 3-321, §**
18 **3-323, § 3-324, OR § 3-602 OF THE CRIMINAL LAW ARTICLE;**

19 5. **ROBBERY UNDER § 3-402 OR § 3-403 OF THE**
20 **CRIMINAL LAW ARTICLE;**

21 6. **CARJACKING UNDER § 3-405 OF THE CRIMINAL**
22 **LAW ARTICLE;**

23 7. **KIDNAPPING UNDER § 3-502 OF THE CRIMINAL**

25 8. **CHILD KIDNAPPING UNDER § 3-503 OF THE**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2010.
