AMENDMENTS TO HOUSE BILL 1304  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Rudolph” and substitute “Rudolph, Barkley, Barnes, Braveboy, Burns, Davis, Feldman, Haddaway-Riccio, Harrison, Hershey, Jameson, Kramer, Love, McHale, Minnick, Olszewski, Schuh, Schulz, Stifler, and Vaughn”; in lines 4 and 9, in each instance, before “owner” insert “business”; in line 6, after “information;” insert “requiring a certain agency that determines a certain violation has occurred to provide a certain notice to the business owner of a bus station or truck stop or the business owner’s agent;”; in line 7, strike “an” and substitute “a business”; in line 8, after “penalty” insert “, if certain signs are not posted within a certain period of time after the business owner receives a certain notice”; and in line 13, after “highway;” insert “defining a certain term;”.

AMENDMENT NO. 2

On page 2, after line 2, insert:

**“(A) IN THIS SECTION, “TRUCK STOP” MEANS A FACILITY:**

**(1) WHOSE PRIMARY PURPOSE IS TO PROVIDE SERVICES TO LONG-HAUL TRUCK DRIVERS; AND**

**(2) THAT PROVIDES:**

**(1) SHOWER FACILITIES TO THE TRUCK DRIVERS FOR A FEE; OR**

(Over)

**(II) PARKING FOR THE TRUCK DRIVERS' VEHICLES.**;

in lines 3 and 12, strike “(A)” and “(B)”, respectively, and substitute “(B)” and “(C)”, respectively; in line 12, strike “THE” and substitute “AN AGENCY THAT ENFORCES THIS SECTION THAT DETERMINES A VIOLATION OF THIS SECTION HAS OCCURRED SHALL NOTIFY THE BUSINESS OWNER OF THE BUS STATION OR TRUCK STOP, OR THE BUSINESS OWNER’S AGENT, OF THE VIOLATION.”

**(2) IF THE BUSINESS OWNER OF THE BUS STATION OR TRUCK STOP DOES NOT POST SIGNS AS REQUIRED UNDER THIS SECTION WITHIN 24 HOURS AFTER RECEIVING THE NOTICE REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE BUSINESS**;

strike beginning with “OF” in line 12 down through “SECTION” in line 13; in line 15, strike “(2)” and substitute “(3)”; in the same line, strike “AN” and substitute “A BUSINESS”; and in line 16, after “THE” insert “BUSINESS”.
