A BILL ENTITLED

1 AN ACT concerning

2 **Horse Racing – Maryland–Bred Race Fund – Administration**

3 FOR the purpose of authorizing the Maryland Racing Commission to allocate a portion
4 of the Maryland–Bred Race Fund to breeder bonuses for horses conceived, but
5 not necessarily foaled, in the State; altering the amount of the Fund the
6 Commission may allocate for certain horse races; requiring the Commission to
7 set the amount of certain breeder awards for races in the State and outside the
8 State; making a technical change; and generally relating to horse racing and the
9 Maryland–Bred Race Fund.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Business Regulation**

23 11–529.

24 (a) In this part the following words have the meanings indicated.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 (b) "Advisory Committee" means the Maryland–Bred Race Fund Advisory
2 Committee.

3 (c) "Fund" means the Maryland–Bred Race Fund.

4 (d) "Fund Race" means a race funded by the Maryland–Bred Race Fund.

5 11–535.

6 (d) On recommendation of the Advisory Committee, the Commission may
7 allocate [not more than 5%] **A PORTION** of the Fund to races [that are restricted to]
8 **AND BREEDER BONUSES FOR** horses conceived, but not necessarily foaled, in the
9 State.

10 11–539.

11 (a) On recommendation of the Advisory Committee, the Commission shall
12 set:

13 (1) the number of Fund Races;

14 (2) the amount of each purse;

15 (3) the date of each Fund Race;

16 (4) the location of each Fund Race held outside the State;

17 (5) the distance of each Fund Race;

18 (6) each breeder's award, **INCLUDING AWARDS FOR RACES IN THE**
19 **STATE AND OUTSIDE THE STATE**; and

20 (7) any other condition needed to carry out the purpose of [a] **THE**
21 Fund [Race].

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 June 1, 2011.
