## A BILL ENTITLED

1 AN ACT concerning

2 **Counties – Kennel Licenses – Requirements for Breeders**

3 FOR the purpose of requiring a certain person to obtain a kennel license under certain  
4 circumstances; requiring each county to collect and maintain certain  
5 information for each kennel license issued; requiring each county to report  
6 certain information to the Department of Labor, Licensing, and Regulation on  
7 or before a certain date each year; authorizing a county to establish additional  
8 kennel license fees to cover certain costs; providing for the construction of this  
9 Act; and generally relating to kennel license requirements.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article 24 – Political Subdivisions – Miscellaneous Provisions**

23 11–501.

24 (a) Except in Calvert County, Carroll County, Cecil County, Montgomery  
25 County, Howard County, Talbot County, and Washington County, on or before the

1 first day of July of each year, the owner of any dog, six months old or over, shall apply  
 2 either orally or in writing, to the county treasurer or to the tax collecting officer in said  
 3 county for a license for each such dog owned or kept by him, and such application shall  
 4 be accompanied by a fee of one dollar (\$1.00) for each male dog or each spayed female  
 5 dog, and a fee of two dollars (\$2.00) for each unspayed female dog, and provided that  
 6 kennel license shall be issued for ten dollars (\$10.00) to persons owning or keeping not  
 7 in excess of twenty-five dogs and that a kennel license fee of twenty dollars (\$20.00)  
 8 shall be issued to persons keeping more than twenty-five dogs. **[The] EXCEPT AS**  
 9 **PROVIDED IN SUBSECTION (A-1) OF THIS SECTION, THE** said license or fee shall be  
 10 the only license or tax required for the ownership or keeping of said dog or dogs. Such  
 11 license shall be issued on a form prepared and supplied by the county commissioners.  
 12 Such license shall be dated and numbered, and shall contain a description of the dog  
 13 licensed. Except in Calvert County, Carroll County, Cecil County, Montgomery  
 14 County, Howard County, Talbot County, and Washington County, all licenses shall be  
 15 void upon the first day of July of the following year. The county commissioners shall  
 16 also furnish, and the county treasurer, or tax collecting officer issuing the license,  
 17 shall issue, with each license, a metal tag. Such tag shall be affixed to a substantial  
 18 collar. The collar shall be furnished by the owner, and with the tag attached shall at  
 19 all times be kept on the dog for which the license is issued, except when confined in  
 20 the kennel or when hunting in charge of an attendant.

21 **(A-1) (1) THIS SUBSECTION APPLIES IN ALL COUNTIES.**

22 **(2) NOTWITHSTANDING ANY OTHER PROVISIONS OF THIS**  
 23 **SECTION, A PERSON SHALL OBTAIN A KENNEL LICENSE FROM THE LOCAL**  
 24 **LICENSING AGENCY IF THE PERSON:**

25 **(I) OWNS OR HAS CUSTODY OF 10 OR MORE UNSPAID**  
 26 **DOGS OVER THE AGE OF 6 MONTHS; AND**

27 **(II) INTENDS TO BREED ANY OF THE DOGS AND SELL ANY**  
 28 **OFFSPRING.**

29 **(3) EACH COUNTY SHALL COLLECT AND MAINTAIN A RECORD OF**  
 30 **THE FOLLOWING INFORMATION FOR EACH KENNEL LICENSE ISSUED IN THE**  
 31 **COUNTY:**

32 **(I) NAME OF THE LICENSEE;**

33 **(II) ADDRESS OF THE LICENSEE;**

34 **(III) NUMBER OF DOGS MAINTAINED BY THE LICENSEE;**

35 **(IV) NUMBER OF PUPPIES SOLD BY THE LICENSEE IN THE**  
 36 **PRECEDING YEAR; AND**

1                   **(v) SALES TAX IDENTIFICATION NUMBER OF THE LICENSEE,**  
2 **IF APPLICABLE.**

3                   **(4) ON OR BEFORE JANUARY 15 OF EACH YEAR, EACH COUNTY**  
4 **SHALL REPORT TO THE DEPARTMENT OF LABOR, LICENSING, AND**  
5 **REGULATION THE INFORMATION COLLECTED UNDER PARAGRAPH (3) OF THIS**  
6 **SUBSECTION FOR THE PRECEDING YEAR.**

7                   **(5) A COUNTY MAY ESTABLISH ADDITIONAL KENNEL LICENSE**  
8 **FEEES TO COVER THE COST OF COLLECTING, MAINTAINING, AND SUBMITTING**  
9 **THE RECORDS AND REPORTS REQUIRED BY PARAGRAPHS (3) AND (4) OF THIS**  
10 **SUBSECTION.**

11                   **(6) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A**  
12 **COUNTY FROM ENACTING MORE STRINGENT KENNEL LICENSING ORDINANCES.**

13                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2011.
