1 AN ACT concerning

2 **Congressional Districting Plan**

3 FOR the purpose of establishing the composition of the eight districts in the State of  
4 Maryland for the election of members to the United States House of  
5 Representatives; specifying certain ward, election district, and precinct  
6 boundaries; making this Act an emergency measure; and generally relating to  
7 the reconfiguration of congressional districts in the State.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That Section(s) 8–702 through 8–709 of Article – Election Law of the  
12 Annotated Code of Maryland be repealed.

17 (a) The population count used after each decennial census for the purpose of  
18 creating the congressional districting plan used to elect the State’s Representatives in  
19 Congress:

20 (1) may not include individuals who:

21 (i) were incarcerated in State or federal correctional facilities,  
22 as determined by the decennial census; and

23 (ii) were not residents of the State before their incarceration;  
24 and

25 (2) shall count individuals incarcerated in the State or federal  
26 correctional facilities, as determined by the decennial census, at their last known  
27 residence before incarceration if the individuals were residents of the State.

28 (b) The State is divided into eight districts for the election of the State’s  
29 Representatives in Congress.

30 (c) (1) The descriptions of congressional districts in this subtitle include  
31 the references indicated.

32 (2) (I) The references to:

1                    [(i)] 1. election districts and wards are to the geographical  
2 boundaries of the election districts and wards as they existed on April 1, [2000] **2010**;

4                    [(ii)] 2. precincts are to the geographical boundaries of the  
5 precincts as reviewed and certified by the local boards or their designees, before they  
6 were reported to the U.S. Bureau of the Census as part of the [2000] **2010** census  
7 redistricting data program and as those precinct lines are specifically indicated in the  
8 P.L. 94-171 data or shown on the P.L. 94-171 census block maps provided by the U.S.  
9 Bureau of the Census and as reviewed and corrected by the Maryland Department of  
10 Planning.
