A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Handgun Permits – Renewal Period for Retired Law**
3 **Enforcement**

4 FOR the purpose of establishing that a handgun permit issued to a retired law
5 enforcement officer of the State or a county or municipal corporation of the
6 State expires on the last day of the holder's birth month following a certain
7 period after the date the permit is issued and may be renewed for successive
8 periods of a certain period each under certain circumstances; and generally
9 relating to handgun permits.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Public Safety**

23 5–301.

24 (a) In this subtitle the following words have the meanings indicated.

1 (d) "Permit" means a permit issued by the Secretary to carry, wear, or
2 transport a handgun.

4 (b) (1) Subject to subsections (c) and (d) of this section, the Secretary may
5 charge a nonrefundable fee payable when an application is filed for a permit.

6 (d) The Secretary may not charge a fee under subsection (b) of this section to:

7 (2) a retired law enforcement officer of the State or a county or
8 municipal corporation of the State.

10 (a) **[A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A**
11 **permit expires on the last day of the holder's birth month following 2 years after the**
12 **date the permit is issued.**

13 (b) **[A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A**
14 **permit may be renewed for successive periods of 3 years each if, at the time of an**
15 **application for renewal, the applicant possesses the qualifications for the issuance of a**
16 **permit and pays the renewal fee stated in this subtitle.**

17 **(C) A PERMIT ISSUED TO A RETIRED LAW ENFORCEMENT OFFICER OF**
18 **THE STATE OR A COUNTY OR MUNICIPAL CORPORATION OF THE STATE:**

19 **(1) EXPIRES ON THE LAST DAY OF THE HOLDER'S BIRTH MONTH**
20 **FOLLOWING 5 YEARS AFTER THE DATE THE PERMIT IS ISSUED; AND**

21 **(2) MAY BE RENEWED FOR SUCCESSIVE PERIODS OF 5 YEARS**
22 **EACH IF, AT THE TIME OF AN APPLICATION FOR RENEWAL, THE APPLICANT**
23 **POSSESSES THE QUALIFICATIONS FOR THE ISSUANCE OF A PERMIT.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2012.
