A BILL ENTITLED

1 AN ACT concerning

2 **Allegany County – Orphans’ Court Judges – Pension**

3 FOR the purpose of altering the pension of a judge of the Orphans’ Court for Allegany
4 County under certain circumstances; making a technical change; and generally
5 relating to the pension of a judge of the Orphans’ Court for Allegany County
6 under certain circumstances.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article – Estates and Trusts**

1 (b) Each of the judges of the Court for Allegany County shall receive an
 2 annual salary set by the County Commissioners in accordance with Article 24, Title
 3 12, Subtitle 1 of the Code. Each judge shall also receive an expense allowance in the
 4 amount of \$600 annually, to be paid at the rate of \$50 monthly.

5 (y) (1) Except in Montgomery, Frederick, Carroll, Talbot, Cecil, Kent,
 6 Queen Anne's, Baltimore, Garrett, and Harford counties and Baltimore City, and
 7 except as provided in paragraphs (3) and (4) of this subsection, a county shall pay a
 8 pension, in the same manner as salaries are paid during active service, to each judge
 9 of the Orphans' Court who:

- 10 (i) Has terminated active service;
- 11 (ii) Has reached 60 years of age; and
- 12 (iii) Has completed at least two terms of office.

13 (2) Except as provided in [paragraph (5) of this subsection] **THIS**
 14 **SECTION**, the salary or pension shall be the greater of:

- 15 (i) \$1,200 annually; or
- 16 (ii) An annual amount calculated at the rate of 4 percent of the
 17 last annual amount of compensation multiplied by the number of years or partial
 18 years of service, not exceeding 12 years.

19 **(6) IN ALLEGANY COUNTY, THE PENSION FOR AN ORPHANS'**
 20 **COURT JUDGE SHALL BE THE GREATER OF:**

21 **(I) \$1,200 ANNUALLY; OR**

22 **(II) 1. EXCEPT AS PROVIDED IN ITEM 2 OF THIS**
 23 **SUBPARAGRAPH, AN ANNUAL AMOUNT CALCULATED AT THE RATE OF 4**
 24 **PERCENT OF THE LAST ANNUAL AMOUNT OF COMPENSATION MULTIPLIED BY**
 25 **THE NUMBER OF YEARS OF SERVICE, NOT EXCEEDING 16 YEARS; OR**

26 **2. AN ANNUAL AMOUNT EQUAL TO TWO-THIRDS OF**
 27 **THE LAST ANNUAL AMOUNT OF COMPENSATION IF THE JUDGE HAS MORE THAN**
 28 **16 YEARS OF SERVICE.**

29 **[(6)] (7)** The pension or salary may be suspended during any month
 30 the judge is a full-time employee of any county or of this State.

1 **[(7)] (8)** Notwithstanding any provision of this section an Orphans'
2 Court judge may not receive a pension under this section if he is receiving any other
3 State pension based on service as an Orphans' Court judge.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2012.
