A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Motor Vehicle Safety Checkpoints – Prohibition on Targeting**
3 **Specific Types of Motor Vehicles**

4 FOR the purpose of prohibiting a police officer at a motor vehicle safety checkpoint
5 from targeting certain types of motor vehicles; providing for the application of
6 this Act; defining a certain term; and generally relating to motor vehicle safety
7 checkpoints.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Transportation**

16 **25–114.**

17 **(A) IN THIS SECTION, “SAFETY CHECKPOINT” MEANS A**
18 **PREDETERMINED FIXED LOCATION AT WHICH A POLICE OFFICER STOPS A**
19 **MOTOR VEHICLE OR A SPECIFIC SEQUENCE OF MOTOR VEHICLES TO CONDUCT**
20 **SAFETY INSPECTIONS, CHECK DRIVER’S LICENSES AND REGISTRATIONS, AND**
21 **EVALUATE DRIVERS FOR IMPAIRMENT.**

22 **(B) (1) THIS SECTION APPLIES TO A SAFETY CHECKPOINT THAT:**

23 **(I) TARGETS THE GENERAL PUBLIC;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 **(II) IS CONDUCTED ON A RANDOM BASIS; AND**

2 **(III) IS NOT CONDUCTED ON SUSPICION OF ILLEGAL**
3 **ACTIVITY.**

4 **(2) THIS SECTION DOES NOT APPLY TO A SAFETY CHECKPOINT**
5 **TARGETING COMMON CARRIERS, MOTOR CARRIERS, TRUCK TRACTORS, OR**
6 **TRAILERS OR SEMITRAILERS.**

7 **(C) A POLICE OFFICER AT A SAFETY CHECKPOINT MAY NOT TARGET A**
8 **SPECIFIC TYPE OF MOTOR VEHICLE.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2012.
