3 FOR the purpose of requiring certain health insurers to provide coverage to men of a
4 certain age for certain medically recognized diagnostic tests used to detect prostate
5 cancer under certain circumstances.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article - Insurance**

21 (A) THIS SECTION APPLIES TO:

1 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE
2 INPATIENT HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR
3 GROUPS ON AN EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES
4 OR CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE; AND

5 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE
6 INPATIENT HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR
7 GROUPS UNDER CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.

15 ~~CANCER OR OTHER PROSTATE CANCER RISK FACTORS.~~

16 (B) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE COVERAGE FOR
17 THE EXPENSES INCURRED IN CONDUCTING A MEDICALLY RECOGNIZED
18 DIAGNOSTIC EXAMINATION WHICH SHALL INCLUDE A DIGITAL RECTAL
19 EXAMINATION AND A BLOOD TEST CALLED THE PROSTATE-SPECIFIC ANTIGEN (PSA)
20 TEST:

21 (1) FOR MEN WHO ARE BETWEEN 40 AND 75 YEARS OF AGE;

22 (2) WHEN USED FOR THE PURPOSE OF GUIDING PATIENT
23 MANAGEMENT IN MONITORING THE RESPONSE TO PROSTATE CANCER TREATMENT;

24 (3) WHEN USED FOR STAGING IN DETERMINING THE NEED FOR A BONE
25 SCAN IN PATIENTS WITH PROSTATE CANCER; OR

26 (4) WHEN USED FOR MALE PATIENTS WHO ARE AT HIGH RISK FOR
27 PROSTATE CANCER.

28 (C) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE THE BENEFITS
29 REQUIRED UNDER THIS SECTION TO THE SAME EXTENT AS FOR ANY OTHER
30 MEDICAL CONDITION UNDER THE ENROLLEE'S OR INSURED'S CONTRACT OR
31 POLICY WITH THE ENTITY.

34 (N) THE PROVISIONS OF § 15-822 OF THE INSURANCE ARTICLE SHALL APPLY
35 TO HEALTH MAINTENANCE ORGANIZATIONS.

37 October 1, 1997.
